THE WILDLIFE CONSERVATION (MANAGEMENT OF WILDLIFE CAPTIVE FACILITIES)
REGULATIONS, 2020

PART I
PRELIMINARY PROVISIONS

- Citation 1 These Regulations may be cited as the Wildlife Conservation (Management of Wildlife Captive Facilities) Regulations, 2020.
- Interpretation 2. In these Regulations, unless the context otherwise requires -
- Cap. 283 “Act” means the Wildlife Conservation Act;
“animal” shall have the meaning ascribed to it under the Act;
“animal capture” means any act directed at the taking of any animal, nest or egg from its natural environment;
“authorised officer” shall have the meaning ascribed to it under the Act;
“CITES” means the Convention on International Trade in Endangered Species of Wild Fauna and Flora of 1973 and includes any Appendices thereto and any Resolutions of the Conferences of parties;
“commercial purpose” means the operation of a wildlife captive facility for any fare, fee, rate, charge or other consideration or indirectly in connection with any business or other undertaking intended for profit;
“consumptive use” means the taking of flora or the hunting or capturing of fauna in accordance with the provisions of the Act or any other relevant law;
“controlled environment” means an enclosed or fenced area which is designed to hold animals in order to prevent them from escaping, for the purpose of facilitating

human intervention or manipulation;

- “cropping” means a regular off-take of surplus specimen for both conservation and economic purposes;
- “culling” means an operation aimed at killing a specific number of specimens of species within the area in order to manage it in accordance with the management plan of the area or within a specified area;
- “Director” means the Director of Wildlife appointed under the Act;
- “Director General” means the Chief Executive of Tanzania Wildlife Management Authority;
- “ex-situ facility” means any lawful facility used in conservation of wildlife outside natural environment;
- “fenced wildlife ranch” means a wildlife ranch which is enclosed;
- “wildlife farm” means an area of a minimum size of 500 hectares but which does not exceed 2000 hectares, kept for the purpose of a multiform utilisation of wildlife where a wide range of consumptive or non-consumptive complementary uses are managed;
- “wildlife orphanage facility” means a place where wild animals incapacitated by reason of physical disability or without parental care, are kept in captivity for their survival;
- “open wildlife ranch” means a wildlife ranch which is not fenced;
- “protected species” shall have the meaning ascribed to it under the Act;
- “wildlife breeding facility” means an area where wildlife species are reared and bred for commercial purposes;
- “wildlife sanctuary” means a place where rare and endangered wildlife specimens are reared in captivity, in a semi-natural state, primarily for breeding purposes;
- “hybridisation” means the cross-breeding of animals from different species or sub species;
- “wildlife ranch” means an area of a minimum size of 2,000 hectares, kept for the purpose of a multiform utilisation of wildlife, where a wide range of consumptive or non-consumptive complementary uses are managed;
- “protected area” shall have the meaning ascribed to it under the Act;
- “wildlife captive facility” means a wildlife ranch, farm, breeding facility, orphanage facility, sanctuary, zoo and any other ex-situ facility;

- “conservation area” shall have the meaning ascribed to it under the Act;
- Cap. 116 “hunting” shall have the meaning ascribed to it under the Act;
“land use plan” shall have the meaning ascribed to it under the National Land Use Planning Commission Act;
“Minister” means the Minister responsible for wildlife;
“non-consumptive use” means the use of scenery, cultural and natural resources that does not involve taking any specimen from the scene, cultural site or from the wild and includes wildlife viewing, bird watching, walking safaris, hiking, canoeing, boating, scuba diving, mountaineering and any other similar or related activity;
“resident hunting” means hunting which is carried out by a resident of Tanzania (citizen or non-citizen) for purposes of obtaining game meat for domestic consumption or commercial purposes;
- G.N NO. 229 of 2010 “resident licence” shall have the meaning ascribed to it under the Wildlife Conservation (Resident Hunting) Regulations;
- G.N NO. 414 of 2015
G.N NO. 243 of 2010 “tourist hunting” shall have the meaning ascribed to it under the Wildlife Conservation (Tourist Hunting) Regulations;
- “Trophy Dealer’s Licence Advisory Committee” means a Committee established under regulation 3(1) of the Wildlife Conservation (Dealing in Trophies) Regulations;
- Cap. 114 “village land” means the land declared to be village land under and in accordance with the provisions of the Village Land Act;
- Cap. 287 “village” means a village registered as such under the Local Government (District Authorities) Act, and for purposes of these Regulations includes such areas as shall be designated by the Director General for the use by traditional communities other than those within the Ngorongoro Conservation Area;
“zoo” means a sheltered facility where wild animals are kept in captivity for recreation, research and educational purposes;
“wildlife” shall have the meaning ascribed to it under the Act.

PART II

ESTABLISHMENT OF WILDLIFE CAPTIVE FACILITIES

Functions of

3. For the purpose of these Regulations, the functions of

the Director General shall include-

- (a) overseeing and providing technical advice on the process of establishing wildlife captive facilities;
- (b) receiving and considering applications for establishing wildlife captive facilities;
- (c) maintaining a Register of all successful applicants of wildlife captive facilities;
- (d) scrutinising all successful applications and making decisions on whether or not a wildlife captive facility should be registered;
- (e) issuing certificates of registration and trophy dealer's licence to successful applicants of wildlife captive facilities;
- (f) issuing a parent stock capture permit for obtaining parent stock from the wild or from wildlife captive facility with the consent of the owner;
- (g) assessing and evaluating the performance of operators in the management of wildlife captive facilities;
- (h) overseeing conservation activities in wildlife captive facilities;
- (i) conducting resource monitoring and inventory;
- (j) monitoring and evaluating animal population trends;
- (k) determining the continuation of wildlife captive facilities including supervising exercise;
- (l) providing guidelines for the development of management plans;
- (m) overseeing the provision of research, extension and training concerning wildlife captive facilities including supervising the exercise;
- (n) issuing permits for various forms of wildlife utilisation in wildlife captive facilities;
- (o) in collaboration with other relevant authorities, provide a wildlife quarantine facility; and
- (p) inspecting wildlife captive facilities.

Establishment of
wildlife captive
facilities

4. (1) Wildlife captive facilities may be established in the following areas:-

- (a) outside any reserved land or conservation area;
 - (b) in a village land as per the land use plan or written approval from the relevant local government authority;
 - (c) in a controlled environment.
- (2) The wildlife captive facilities established under

subregulation (1) shall be managed in accordance with the provisions of these Regulations.

(3) The wildlife orphanage facilities shall be established and managed by a Government institution or non-profit making organisation or a Government institution in collaboration with a non-profit making organisation:

Provided that, where a non-profit making organisation intends to establish a wildlife orphanage facility, approval shall be sought from and granted by the Director General.

Applications for registration of wildlife captive facilities

5.-(1) Any person who desires to operate or establish a wildlife captive facility shall submit an application for registration to the Director General in the form set out in the First Schedule to these Regulations.

(2) The Director General shall open the window for applications for registration of wildlife captive facilities in each quarter of the year.

(3) The application form referred to under subregulation (1) shall, except where the application is for the establishment of a wildlife orphanage facility, be accompanied by proof of payment of the application fees set out in Part 1 of the Second Schedule to these Regulations.

(4) A person shall not operate a wildlife captive facility unless he has paid the registration fees set out in Part II of the Second Schedule to these Regulations and holds a valid certificate of registration issued by the Director General in the manner prescribed under the Third Schedule to these Regulations.

Qualification for registration of wildlife ranch, farm, breeding facility, zoo or sanctuary

6. The Director General shall, in considering the applications for registration of a wildlife ranch, farm, breeding facility, zoo or sanctuary, have regard to the following:

- (a) that the applicant is a holder of a right of occupancy over the land intended to be used as a wildlife ranch, farm, breeding facility, zoo or sanctuary;
- (b) that the applicant is a citizen of the United Republic of Tanzania and in the case of a body corporate at least 51% of the shares are held by citizens of the United Republic of Tanzania;
- (c) that the proposed activity conforms to the land use plan of the area or the use is approved by the relevant local government authority;
- (d) that the business plan relates to the proposed undertaking;

- (e) an Environmental Impact Assessment certificate for wildlife captive facility that shall involve animals prescribed in the Fourth Schedule to these Regulations;
- (f) that the applicant is prepared to micro-chip or to mark each specimen of a species as per procedure;
- (g) that the application is in line with the guidelines issued by the Director General;
- (h) that the applicant has paid the required fees;
- (i) that the applicant has complied with other relevant laws; and
- (j) any other requirement that the Director General may consider necessary.

Registration of

7. The Director General shall, in considering an application for registration of a wildlife orphanage facility, have regard to the following:

- (a) that the applicant is a holder of a right of occupancy over the land intended to be used as wildlife orphanage facility;
- (b) that the applicant has an approved veterinary clinic managed by veterinary officers;
- (c) that the applicant has hired or engaged a veterinary officer with wildlife knowledge;
- (d) that the applicant has holding ground set out for holding rescued animals while undertaking parental care or treatment;
- (e) that the proposed activity conforms to the land use plan of the area or the use is approved by the relevant local government authority;
- (f) that the applicant has submitted a project proposal containing, among other things, the type of animals that can be accommodated;
- (g) that the application is in line with the guidelines issued by the Director General;
- (h) that the applicant submits an Environmental Impact Assessment certificate for the proposed facility;
- (i) that the applicant is a Government institution or a non - profit making organisation;
- (j) that the applicant has complied with other relevant laws; and
- (k) any other requirement that the Director General may consider necessary

Registration of

8. Where the Director General is satisfied that an

application has been duly made in accordance with these Regulations, he shall cause the applicant to be registered.

Consideration of
applications

9. (1) The Director General shall, within fourteen days upon expiry of the time specified under sub regulation 4(2)–

- (a) nominate a team of at least three authorised officers to inspect the premises in respect of which the application has been lodged;
- (b) instruct the team to submit within twenty one days from the date of appointment, written recommendations as to whether–
 - (i) the application has to be accepted or rejected; or
 - (ii) the application should be accepted on conditions.

(2) The Director General shall, upon receipt of the team’s written recommendations, submit the same to the Trophy Dealer’s Licence Advisory Committee which shall scrutinise the recommendations and advise the Director General accordingly.

(3) After considering the advice of the Advisory Committee, the Director General may–

- (a) grant a certificate of registration and a trophy dealer’s licence subject to certain conditions; or
- (b) reject the application and provide reasons thereof.

(4) The Director General shall, within ten working days after making a decision on an application, notify the applicant in writing and any other person who lodged an objection against the application, of his decision.

Certificate of
registration

10.-(1) The Director General shall maintain a Register where all successful applicants shall be registered.

(2) Once the Director General makes a decision to register a wildlife captive facility, he shall issue a certificate of registration to the applicant in the form set out in the Third Schedule to these Regulations.

(3) In case of a wildlife ranch, farm, breeding facility, zoo or sanctuary the Director General shall, in addition to the certificate of registration, issue the applicant with a trophy dealer’s licence.

(4) The certificate of registration shall be valid for ten years subject to renewal and shall not be transferable.

(5) In deciding whether or not to grant an application for renewal of a certificate of registration, the Director General shall have regard to the same considerations provided for under

regulation 5 or 6 of these regulations as the case may be.

(6) The trophy dealer's licence shall be renewable annually and shall be subject to the conditions prescribed in the Wildlife Conservation (Dealing in Trophies) Regulations.

(7) Throughout the period of its validity, a certificate of registration shall be displayed in a conspicuous place at the wildlife captive facility.

Revocation,
cancellation and
suspension of
registration

11. (1) The Director General may revoke, cancel or suspend any certificate of registration issued under these Regulations where the person to whom the certificate of registration is granted-

- (a) is convicted of an offence under the Act; or
- (b) contravenes any of the terms or conditions of registration under these Regulations or any other relevant law.

(2) Where the Director General revokes, cancels or suspends any certificate of registration, he shall order the holder of the certificate to immediately surrender it to him and appoint a competent authority to oversee the operations of the respective wildlife captive facility.

12. A certificate of registration issued in respect of a wildlife captive facility other than a wildlife orphanage facility, shall be subject to conditions that the person to whom the certificate of registration is granted, shall-

- (a) prevent hybridisation or inbreeding;
- (b) keep a record book of all animals kept in the wildlife captive facility;
- (c) provide information relating to paragraphs (b) to the Director General within three months after the end of each calendar year;
- (d) ensure that animals are kept in controlled environment except for open wildlife ranches;
- (e) in case of a wildlife ranch established within the distance of one kilometer from the borderline of protected areas, ensure that it is an open wildlife ranch; and
- (f) safeguard the welfare and safety of animals kept in the wildlife captive facility

Restrictions on

facility

13.- (1) Animals to be kept in a wildlife orphanage facility shall only be those incapacitated by reason of physical disability or without parental care.

(2) An animal shall not be transferred to a wildlife

orphanage facility without the permission of the Director General being previously sought and obtained.

(3) Upon recommendation of the wildlife veterinary officer, the Director General shall order the removal of an animal from the wildlife orphanage facility.

(4) Utilisation of wildlife, whether consumptive and non-consumptive, shall not be permitted in a wildlife orphanage facility.

(5) An operator of a wildlife orphanage facility shall not be entitled to claim any refund in respect of the disposal of a wild animal from the wildlife orphanage facility.

PART III

ADMINISTRATION OF WILDLIFE CAPTIVE FACILITIES

Submission and approval of management plan

14. (1) Every operator of a wildlife captive facility shall develop a management plan.

(2) Every management plan shall be submitted to the Director General for approval prior to the commencement of any activity within the wildlife captive facility.

(3) The Director General shall issue guidelines on the format, content and procedures for preparation and submission of the management plan.

Monitoring and evaluation of wildlife captive facilities

15. (1) The Director General shall monitor and evaluate the performance of wildlife captive facilities.

(2) The Director General shall undertake assessment of the performance of wildlife captive facilities in terms of social, economic and biodiversity conservation impacts in accordance with the set guidelines.

Application of land laws

16. The relevant laws relating to land shall be applicable when setting aside, reserving or transferring any area of village land to general or reserved land or granting the right of occupancy to any person or a group of persons for the purposes of operating a wildlife captive facility.

PART IV

MANAGEMENT OF WILDLIFE CAPTIVE FACILITIES

Employment of Tanzanian citizen

17.-(1) The operator of a wildlife captive facility shall employ a Tanzanian citizen with wildlife knowledge from a recognised institution to manage the facility.

(2) Without prejudice to subregulation (1), every operator of a wildlife captive facility shall employ or hire a

wildlife veterinary officer with wildlife veterinary knowledge from a recognised institution who shall be responsible for attending the animals.

Protected species

18. Any protected species shall not be confined to or kept in a wildlife captive facility without consultation with the Director of Wildlife and written approval of the Director General.

Parent stock capture conditions

19.-(1) An operator of wildlife captive facility intending to acquire a parent stock from the wild shall apply for a parent stock capture permit to the Director General in the form set out in the Fifth Schedule to these Regulations.

(2) Capturing of parent stock shall be conducted in accordance with the Wildlife Conservation (Capture of Animals) Regulations.

(3) Without prejudice to the generality of subregulation (2), an operator of a wildlife captive facility shall-

(a) submit to the licensing officer a copy of issued quota from the Director General;

(b) carry out capturing of a parent stock under the supervision of officers approved by the Director General and pay all the necessary costs incurred in the process;

(c) pay parent stock price set out in the Sixth Schedule to these Regulations;

(d) permanently mark the acquired parent stock in the modality set by the Director General.

(4) An operator of a wildlife captive facility shall not dispose of any parent stock without the consent of Director General.

Registration of facilities that keep CITES Appendix I species

20. Every wildlife captive facility that keeps species or sub-species listed in CITES under appendix I for commercial purpose, shall be registered with the CITES Secretariat.

Capturing or cropping at night

21. Capturing or cropping of species in a wildlife captive facility shall not be conducted at night unless permission of the Director General has been obtained.

Maintaining register of animal species

22.-(1) Every operator of a wildlife captive facility established in a controlled environment shall keep a register of animal populations in the wildlife captive facility including any off-take, dead or new born animals.

(2) Every operator of a wildlife captive facility established in a controlled environment shall submit to the Director General a quarterly report of animal population kept in that wildlife captive facility.

(3) The death of any animal in the wildlife captive facility shall be reported in writing to the Director General and such report shall be accompanied by a post-mortem report.

(4) Registration and issuance of certificate of ownership for newly born animals in a controlled environment shall involve payment of 5% of parent stock price set out in the Sixth Schedule to these Regulations.

23.-(1) Capture of live animals in a wildlife open ranch shall be conducted in accordance with the Wildlife Conservation (Capture of animals) Regulations.

(2) An operator of a wildlife captive facility established in a controlled environment who intends to capture animals for live animal trade shall-

- (a) submit to the Director General a list containing the number of animal species to be captured; and
- (b) pay 10% of parent stock capture fee, for every animal captured in the wildlife captive facility.

Non-
consumptive

24. (1) Non-consumptive wildlife utilisation in the wildlife open ranch shall be conducted in accordance with the Wildlife Conservation (Non-consumptive Wildlife Utilisation) Regulations.

(2) Non-consumptive wildlife utilisation in wildlife captive facilities established in controlled environment shall be subject to payment of wildlife user right fee set out in the Seventh Schedule to these Regulations.

Consumptive

25. (1) Consumptive wildlife utilisation shall not be conducted in an open wildlife ranch unless an operator of the said facility obtains a written permission from the Director General.

(2) An operator of a wildlife captive facility, other than a wildlife orphanage facility, who intends to conduct consumptive use of wildlife shall adhere to the following conditions:

- (a) submission to the Director General of a list containing the number of animal species to be hunted in respect of tourist or resident hunting;
- (b) payment to the Authority of 10% of game fee payable for every animal hunted in the wildlife

- captive facility, in accordance with the Wildlife Conservation (Tourist Hunting) Regulations and the Wildlife Conservation (Resident Hunting) Regulations, in respect of tourist hunting or resident hunting as the case may be;
- (c) approval of the Director General is sought for any other consumptive use.
- Specific agreements on CITES listed species
26. A wildlife captive facility that breeds CITES listed species shall be subjected to specific agreements between relevant authorities and the operator of the facility in consultation with the Director General.
- Restrictions on transportation and re-introduction of animal species into the wild
27. An operator of a wildlife captive facility established in a controlled environment shall not, unless he obtains a written permission from the Director General-
- (a) transport any wild animal species to or from a wildlife captive facility;
- (b) re-introduce into the wild any wild animal species from a wildlife captive facility; or
- (c) re-introduce in the wildlife captive facility any wild animal species from the wild.
- Donation of game animals
28. The Director General may request an operator of a wildlife captive facility to donate game animals for re-introduction into the wild.
- De-registration of wildlife captive facilities
29. (1) An operator of a wildlife captive facility may apply to the Director General for de-registration of a wildlife captive facility.
- (2) An application for de- registration referred to under subregulation (1) shall be accompanied with the following:
- (a) reasons for application of de-registration;
- (b) an inventory of animal species in the respective wildlife captive facility, indicating their health status, methods to be used in disposing of the animals and their welfare.
- (3) The Director General shall, upon receipt of an application for de- registration of a wildlife captive facility and upon being satisfied that all requirements have been fulfilled, de - register the wildlife captive facility.

PART V
OFFENCES AND PENALTIES

Offences and penalties

30. Any person who contravenes the provisions of these Regulations commits an offence and shall, on conviction, be liable to a fine of not less than three million shillings but not exceeding ten million shillings or to imprisonment for a term of not less than one year but not exceeding three years or to both, and revocation of a certificate of registration.

PART VI
MISCELLANEOUS PROVISIONS

Guidelines

31. The Director General may issue guidelines to facilitate effective implementation of these Regulations.

Appeals

32 (1) Any person who is aggrieved by the decision of the Director General under these Regulations may, within thirty days from the date of receiving the decision, appeal to the Minister.

(2) The Minister shall, within a period of thirty days, make a decision

(3) Any person who is aggrieved by the decision of the Minister may lodge an application for judicial review to the High Court.

33. (1) The Wildlife Conservation (Wildlife Ranching, Farming, Breeding Sites, Orphanage Centers, Sanctuaries and Zoos) Regulations 2013 are hereby revoked.

(2) Notwithstanding the revocation under subregulation (1), anything done, any action taken or any permit, certificate or licence issued under the revoked Regulations shall be deemed to have been done or issued, as the case may be, under the provisions of these Regulations.
